
Harrah Heritage Fest Chili Dog Fun Run

- If you drop an item you can either pick it up and continue or go back and get another.
- You may NOT start eating or drinking until you have a fully assembled meal at Pit Stop 3!
- You may NOT cross the finish line until you have finished eating <u>one fully assembled chili dog and consumed one beverage!</u>
