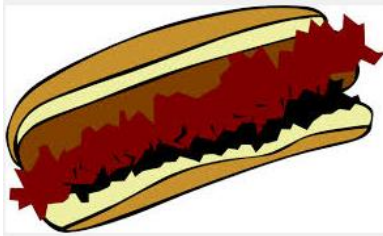


Harrah Heritage Fest Chili Dog Fun Run

1st PLACE Trophy

All entrants receive a free chili dog, beverage, and tasting bowl for the Heritage Fest Chili Cook-Off

Untimed one mile run/walk around the Heritage Park Trail where you must assemble and eat a chili dog and drink one 12oz beer (must be 21) or soft drink.

Starting Line - The Bun

Pit Stop #1 - The Weenie

Pit Stop #2 - The Beverage

Pit Stop #3 - The Chili (Time to eat and drink)

Finish Line - Victory!

- You must have your ID present to choose beer as your beverage!
- If you drop an item you can either pick it up and continue or go back and get another.
- You may NOT start eating or drinking until you have a fully assembled meal at Pit Stop 3!
- You may NOT cross the finish line until you have finished eating one fully assembled chili dog and consumed one beverage!
