LIGHTS ON! Food Vendor Guidelines

COST: A \$25 fee will be assessed to vendors at the 2018 Lights On! festival. All revenue retained by vendor.

LOCATION: Lights On! will take place between 1st & 3rd Streets on Main Street. Vendor locations to be determined.

ELECTRICITY: Vendor must let the Jenks Chamber know of all electrical needs at time of application, both the voltage and amperage.

SETUP: Vendor can begin setup at 4 p.m. on the day of the festival, unless other arrangements are made with the Jenks Chamber. Setup must be complete by 5 p.m., ready for inspection from the Tulsa County Health Department (if applicable).

TEAR DOWN: Early tear down is not permitted.

HEALTH PERMIT: A Tulsa County Health Department permit must be displayed to the public by the vendor. Vendor must be ready for inspection by the Tulsa County Health Department on the day of the festival.

SALES TAX: Sales tax must be collected for any sales. The sales tax rate in Jenks is 8.417%. Please notify us if you have a sales tax ID.
