

## CABIN RENTAL RULES AND REGULATIONS

The cabins are filled by reservation only based on availability. One night's deposit is required to hold your reservation. If your deposit is not received by the specified date of request you automatically cancel your reservation.

- **Check-in time is 3:00 pm, No Exceptions.** Check in time is between 3:00 pm and 4:30 pm. Should you arrive after 4:30pm your keys will be placed in the key box next to the office door. Check the sign on the office door to verify which Cabin you will be in. Your keys will be in the corresponding key box. The combination will be the last four digits of the phone number given when making the reservation. There are signs throughout the park to guide you to the cabins.
- **Check out time is 11:00 am, No Exceptions.** Please return the keys to the park office and submit payment if you arrived the night before and your keys were in the key box. If you are staying more than one night and your keys were in the key box please submit payment as soon as possible.
- No RVs or tent camping are allowed in the cabin area.
- Only 2 vehicles allowed per cabin.
- Only registered cabin guests are allowed in the cabin area after 7:00 p.m.
- No Parties or large gatherings allowed. The cabins are for lodging and every effort should be made to keep it a peaceful area.
- Weddings and other ceremonies require a use permit to be filled out and approved by the park manager.
- A (\$15.00) fifteen-dollar per day non-refundable fee for each pet will be charged upon rental. This fee covers extra cleaning costs incurred during the pet's stay. Pet owners will be responsible for the repair or replacement of any items stained or damaged by pets. Added fees due to excessive amounts of hair removal will be charged at a rate of \$15.00 per 30 minutes of additional cleaning time. Guests, who choose not to register their pet, then occupy a cabin or cottage not designated for pet occupancy, will be charged a damage fee of \$100 in addition to the regular nightly room rate. These damage fees will cover the added time and cleaning expense to make the cabin is dander free for future guests who might be allergic to pets.
- Per State of Oklahoma laws, no smoking or vaporized/electronic cigarettes are allowed in the cabins.
- There is a charge of \$5.00 for 5-6 pieces of firewood that is specially cut for the cabins.
- All furniture must stay inside the cabins including couch cushions.
- Park designated parking spots only.
- There is a 2 night minimum stay for cabins during the dates of May 15<sup>th</sup> through Labor Day.
- Notice of cancellation for the cabins shall be received by mail or telephone at least 5 days in advance of the occupancy date or the deposit will be forfeited.
- Per State Park Regulation 725:30-4-1, Preservation and protection of natural, cultural and archaeological resources, the following is prohibited in state parks: (1) Possessing, destroying, injuring, defacing, removing, digging, killing, or disturbing from its natural state: (A) Living or dead wildlife or the parts or products thereof, such as antlers, nests, or skins. (B) Plants or trees or any parts thereof. (C) Non-fossilized and fossilized paleontological specimens, cultural or archaeological resources, or the parts thereof.
