## Firearms/Hunting Safety Waiver

I \_\_\_\_\_\_, hereby, understand and agree to the following terms of safety while hunting and participating in the services that Honker Hunts has provided to me.

I understand and agree to the following:

- 1. I will keep my firearm pointed in a safe direction at all times.
- 2. I will keep the safety engaged on my firearm until I am ready to shoot.
- 3. I will keep my firearm unloaded until instructed to load it by my guide.
- 4. I will keep my firearm pointed only in my shooting zone designated by my guide.
- 5. I am responsible for my own personal protective equipment, I understand that Honker Hunts will provide any reasonable personal protective equipment that I feel like I need at no cost.
- 6. I understand that I will not shoot wounded birds that are on the ground unless instructed by my guide, this is to protect the hunting dog that is present on the hunt.
- 7. My firearm is capable of holding a maximum of 3 rounds of ammunition.
- 8. I understand that the ammunition provided by Honker Hunts is non-toxic or steel shot which is compliant with the current hunting regulations and requirements, and that any ammo I bring to the blind with me must be compliant with the same regulations for hunting waterfowl.
- 9. I have purchased and verified with my guide that I have all the correct licensing needed to participate in this service provided by Honker Hunts.
- 10. I understand the daily bag limits, possession limits, and all applicable laws that apply to the service that I am partaking in today, which has been seen in the Oklahoma Department of Wildlife Conservation's Hunting Guide.
- 11. I have read and understand the proper laws regarding legally transporting the birds that I have harvested, and will follow all necessary laws regarding this activity.

- 12. I understand that I am responsible for all birds that I potentially wound, and that I, or the guide must make a reasonable/exhaustive effort to recover the bird.
- 13. I understand that if I wound a bird and cannot recover it, it is counted toward my daily bag limit.
- 14. I understand that "party shooting" is against the law.
- 15. I will keep track of which birds I shoot.
- 16. I will notify the guide of which birds I did or did not harvest.
- 17. I understand that if I do not claim the birds that I harvested then the guide will be forced to stop the hunt.
- 18. I will fill out a "Toe Tag" prior to the hunt and will keep it with me and my birds during the hunt to properly label and claim the birds I have harvested during the hunt.
- 19. I will show respect to the landowners property and leave it better than I found it.
- 20. I will not drive into fields.
- 21. I will not leave any gates open which are closed for any reason.
- 22. I will not contact any landowner that is associated with, or doing business with Honker Hunts in regards to my hunt or any future hunts that I wish to participate in, as to take business away from Honker Hunts.
- 23. I attest that I am not under the influence of alcohol or any narcotic drug that might affect my decision making ability.
- 24. I understand that by signing this agreement, I give up my legal rights to hold Honker Hunts or the landowner, legally responsible for any incident, accident, or damages that occur to myself or my property while participating in the service that Honker Hunts has provided to me.
