**WAIVER AND RELEASE FROM LIABILITY

I, _____, hereby Waive and Release, indemnify, hold harmless and forever discharge The City of Cache OK, and/or the Cache Area Chamber, and all its agents, employees, officers, directors, affiliates, successors, managers and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I ever had or may have, arising from or in any way related to my participation in the Cache Christmas Parade conducted by the Cache Area Chamber and/or the City of Cache, provided that this waiver of liability does not apply to any acts of gross negligence, or international, willful or wanton misconduct by third parties, associates, designees or persons affiliated with the Cache Chamber of Commerce or the City of Cache.

I have evaluated and inspected the premises and or event activity and believe them to be satisfactory for the purpose of this activity. I understand that the activities or function in which I participate during the Cache Christmas Parade may be inherently dangerous and can cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. On behalf of myself, my heirs, assigns, and next of kin, I waive all claims for damages, injuries and death sustained to me or my property that I may have against the aforementioned released parties to such activity.

By signing this Waiver, I assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with and including, but not limited to using the facility, property, and/or equipment in any manner, form or fashion, and practicing and/or engaging in the Cache Christmas Parade.

This Waiver and Release contains the entire agreement between the parties, and supersedes any prior written or oral agreements between the parties concerning the subject matter of this Waiver and Release. The provisions of this Waiver and Release may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of the Waiver and Release will continue to be in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of the Cache Area Chamber and/or City of Cache, whether by agreement, by operation of law, or otherwise for injuries to persons or property during the Cache Christmas Parade.

I have read, understand and fully agree to the terms of this Waiver and Release. I understand and confirm that by signing this Waiver and Release I have given up any future legal rights. I have signed this agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional Waiver and Release of all liability to the full extent of the law.
