Sequoyah State Park is located in Eastern Oklahoma on the shores of Fort Gibson Lake. The park is a haven for water lovers and outdoor enthusiasts with over 19,000 surface areas of water and 225 miles of shoreline. The park has tennis courts, volleyball courts, playgrounds, fishing areas and 12 miles worth of hiking trails. The park's swim beach is located along the lake in the Choctaw Tent campground. The Three Forks Nature Center is located just before the Choctaw camp area and provides program activities. Fee activities within the park include hayrides, boat rentals and golf. There is a \$10.00 fee for day use/ parking per vehicle.

A-FRAME CABINS

Cabin 1 sleeps 4 and has a shower and bathroom. *Cabins 2-10* sleeps 10. There is a dorm style bathhouse with separate men's and women's facilities. The bath house has 5 sinks, 5 toilets and 5 heated showers. The *cook's quarters* in the Community Building sleeps 4 and has a shower and a bathroom. Guest furnish their own bedding and toiletries.

RATES

Group Camp rates start at \$350.00 per night on weekdays and \$375.00 per night on weekends (Friday & Saturday). Five cabins including the cook's quarters are initially opened for up to 48 people. For each additional cabin opened, there is a \$25.00 per night per cabin fee. A cleaning deposit of \$200.00 is charged in addition to the first night fee. Upon check out, the cleaning deposit is applied to the balance due, provided the areas used are clean and in order. Tents, RVs and pets will be charged same rate applied to campgrounds.

COMMUNITY BUILDING

The Community Building may be rented separately. It runs \$200.00 per day with a \$200.00 refundable cleaning deposit. Parking passes are only included while in Group Camp area.

APPLICATION AND RESERVATION PROCESS

Applications are accepted 12 months in advance and may be obtained by contacting the Park Office. Applications shall be completed in full, define an alternate date and shall be emailed or mailed directly to the Park Office. Reservations for groups requesting the use of the group camp for 5 consecutive days or more shall be accepted and confirmed on a first come, first served basis upon Manager's discretion. Reservations for groups requesting the use of group camp for less than 5 consecutive days or more shall be accepted and confirmed after January 1st of each year. The number of reservations is not limited during any single season, and the Park Manager shall give consideration to serving the greatest numbers of groups and the maximum number of persons. In addition, the Park Manager may determine the length of the reservation so that the successive reservations will result in the greatest occupancy of the group camp. Such determinations shall be based upon the reservation type, size and activities.

If an application is accepted, a request for reservations deposit shall be equal to the first night's rate and cleaning deposit. It shall be presented to the Park Office within 14 days (excluding Sundays) from the day the request for deposit was presented from the Park Office or the reservation may be cancelled. Upon receipt of the deposit the reservation will be confirmed through a contract agreement. Once confirmed, a reservation will not be cancelled or changed to accommodate any other group. Cancellation of reservations shall be made by the group representative 60 days in advance of the occupancy date which is listed on the confirmed contract or the deposit shall be subject to forfeiture.

PARKING PASSES

Parking passes are included during the length of stay. A list of license plates needs to be submitted to the Park Office 24 hours in advanced for registration. Failure to properly register vehicles with the Park may result in parking violations that will be the responsibility of the individual responsible for the vehicle.
