

**All vehicles must visibly display a parking permit while parked at any of the designated parking locations labeled on this map.**

### WATERFOWL HUNTING

- Waterfowl hunting is only allowed in the designated areas shown on the map. **Please note that the Clear Bay arm of Lake Thunderbird (The area south of the Turkey Pass Boat Ramp and east of 108<sup>th</sup> Avenue) is closed for the September teal season.**
- Waterfowl hunting closes at 1:00 PM DAILY. Consult the current Oklahoma waterfowl hunting regulations for open dates, open shooting hours and bag limits. Shotguns are the only legal means of take allowed at Lake Thunderbird. Federally approved, non-toxic conventional B.B. shot or smaller, must be used.
- Temporary blinds only. **Blinds must be removed at the end of each day's hunt.** No living vegetation may be used for construction of a blind. A camouflage boat is considered a temporary blind.
- All hunting other than that done from boats must occur within fifty (50) yards of the shoreline or streambank.

### ARCHERY DEER HUNTING

- Archery-only deer hunting is allowed in the designated areas shown on the map.
- Consult the current Oklahoma hunting regulations for open dates, shooting hours, bag limits, and legal means of take.
- **The use of bait or baiting is prohibited.** Bait is defined as the placing, depositing, exposing, distributing or scattering of shelled, shucked or unshucked corn, wheat or other grain, or other feed.
- No permanent type stands may be constructed in or on a tree nor shall cleats be driven into a tree to gain access to a portion of any tree nor shall any person hunt from such a stand. **Only portable type stands, that do not require the use of any fastening device that has the potential of damaging a tree, are permitted.**
- Stands shall be removed from the tree immediately following the closure of the hunt for which they were used with a limit of no more than 14 days. Stands remaining after this time become the property of the OTRD to be disposed.

Except for the specific variations outlined here, all current Oklahoma hunting regulations shall apply.



### PARKING PERMIT INFORMATION

- The parking locations on the map provide public access to undeveloped areas of the park for dispersed recreation activities such as hunting, fishing, birdwatching, or hiking.
- Parking permits are available for purchase online at [rv.okparks.com](http://rv.okparks.com) or through the office. **Permits are only valid for the calendar year in which they are purchased.**
- Please be aware of your surroundings and courteous to other visitors, especially during hunting season. **Please report suspicious or illegal activity to the park office or by calling 911.**

### GENERAL PARK REGULATIONS

- Disposal of garbage, trash, refuse, litter, sewage, debris or any other form of solid waste in the park is prohibited.
- No person shall use threatening, abusive, or indecent language, participate in a disorderly assemblage, nor publicly appear nude or intoxicated.
- No person shall remove any historical, cultural or archaeological artifacts (including arrowheads).
- Metal detectors are not allowed at Lake Thunderbird.
- Vehicles are restricted to developed park roads and designated parking areas. All-Terrain Vehicles are prohibited.
- **Overnight camping and campfires are prohibited outside of developed campgrounds.**

### GENERAL HUNTING REGULATIONS

- The only hunts permitted at Lake Thunderbird State Park are archery deer and waterfowl. Hunters must have their hunting license with them at all times.
- **Hunting is only allowed during the open season in the designated areas shown on the map.**
- Shotguns are only permitted in the park during the open hunting season. Visitors carrying these weapons must also possess a valid hunting license. All other firearms are prohibited except under the provisions of the Oklahoma Self Defense Act and the Oklahoma Firearms Act.
- Be aware of your surroundings and know what you are shooting at. Other visitors may be in the hunting areas.
- **All shell casings and other disposable materials must be carried out by the hunter when leaving the hunt area.**
- Damage or removal of any state controlled or owned property including, but not limited to signs, fences, gates, buildings, trees, shrubs, crops, picnic tables and grills is prohibited. **Please remember that the future of these hunts depend upon the conduct of you, the hunter.**
